HOW TO ENTER

- 10. Entrants must spend a minimum of \$15 at any Participating Retailer (refer to Annexure A) in the Participating Precinct (**Eligible Purchases**) and upload a copy of the receipt to the competition entry form via the Participating Precinct's website.
- 11. Receipts cannot be accumulated to meet the minimum spend of \$15.
